The university aims to accomplish this objective through focused excellence in teaching, an efficient research environment and ample opportunities for outreach to the community, thereby addressing higher educational endeavours - teaching, research and service. Their role is essential in maintaining compliance with regulatory standards and ensuring the long-term success of the University.

The University functions through a well-defined structure having a clear articulation of all governance bodies in place as per the statutes and requirements of regulatory bodies through Governing Body, Board of Management, Academic Council, Finance Committee, Internal Quality Assurance Cell and other various cells and committees having representation of diverse stakeholders.

The University has well defined processes to capture various aspects of governance with clearly defined deliverables and outcomes.

#### 2. Financial Enablers and Funding Models (Resource Generation)

Sardar Vallabhbhai Global university is a private self-financed university.

Finance committee of the university ensures optimum utilisation of resources and work to implement development plan prepared by the university.

University has formulated plans to support various academic initiatives, cutting-edge research endeavours, commensurate development of the physical infrastructure, to support startups through its incubation centre and achieve objects outlined in vision and mission statements of the University.

Finance committee prepares budget in consultation with academic council and submits it to Board of Management for approval.

The Annual reports of the University are prepared, and the accounts & financial statements are audited regularly.

#### 3. Academic Enablers

Academic Structure and Academic Programs are the essential part of any university. The academic structure has been devised after considering the scenario of industry and education and subsequent consultation with other sector specific stakeholders and experts.

The University strives to create an enabling and conducive teaching-learning environment for holistic development of the students. The University has a well-defined structure and fully functional academic bodies that play a pivotal role in overseeing the academic curriculum, ensuring that the courses offered align with educational standards and the University's institutional objectives. The University has made significant progress in aligning its curriculum with the evolving demands of industry. The University has revamped its courses to focus on skill development, value addition, and employability.

At university, the need and suggestions from the faculty for revision in the curriculum are put for consideration in Board of Studies and subsequently updated. Board of Studies approves Framework design, Teaching Scheme, Detailed Syllabus and Evaluation process. Recommendations of Board of Studies are presented to Academic Council for Approval. Board of Management considers recommendations of Academic Council regarding courses and curriculum.

The academic programs at the University provide a combination of inter-disciplinary core and elective courses along with extra activities, project work and industry internships to augment student's intellectual capability. Courses are taught in modular form. All courses and curriculum designed in line with NEP 2020.

#### 4. Research and Intellectual Property Enablers

The University through its legacy of cutting-edge research and innovation has made a significant impact in addressing the challenges faced by the society at large. The University, through its Research and



Development Cell, encourages researchers to engage in collaborative initiatives in diverse fields. With a multi-disciplinary approach to research, the University fosters an environment of generating ground breaking ideas which yield valuable intellectual property.

The University shall look into the development of several innovative and quality research initiatives in all programs, driven by global trends, societal needs, and advances in technology.

Implementing a research-based curriculum and increasing student intake closely aligns with the newly introduced Undergraduate Curriculum Framework (UGCF) under the National Education Policy (NEP) 2020. This framework promotes a multidisciplinary approach, equipping students for advanced academic and professional careers. To enhance the academic and research experience, the project work integral to both undergraduate and postgraduate programs need a more streamlined and effective process.

The University is actively engaged in identifying and supporting new fields of research across various disciplines. With a focus on interdisciplinary collaboration, it is working towards enhancing its research infrastructure, including providing necessary resources such as laboratories, equipment, and research assistants. Faculty members are encouraged to explore emerging fields, and the institution regularly analyses trends in research funding and industry needs to prioritize high-potential areas. In terms of partnerships, the University has considerable connections with industry and other research institutions for joint projects. However, there is a growing need to strengthen these collaborations further to increase both the scope and impact of research initiatives. In addition to its teaching mission, its departments are actively involved in research, utilizing both internal and external resources. The University research community envisions a system prepared to take up future research and developmental challenges.

The university is regularly organising national and international conferences every year. The university regularly organises workshops, FDPs, and other academic activities to strengthen its research output. Students at the university are also involved in publishing papers / cases studies. University has subscribed national and international journals, online databases in its central library and sought



membership in renowned institutions in India. The university is home to organising many competitions to sharpen the innovative skills of the students.
